This website consists of the *Papers* of Clay T. Whitehead (1938-2008) as Special Assistant to President 1968-1970, Director of the Office of Telecommunications Policy (OTP) 1970-74, Director of the (Gerald R.) Ford Transition Team 1974, and subsequent industrial and entrepreneurial ventures including the founding of Hughes

Communications and its the Galaxy system, the first cable dedicated satellite, and ASTRA, an innovation as the first commercial Pan-European television satellite system and displacer of state-owned television in Europe. His original intent in digitizing the White House and OTP *Papers* was to aid research for the book he was writing at the time of his death. The text of this work in progress, *The History of 20th Century Telecommunications: The Development and Regulation of Telecommunications and Broadcasting*, as well as the archival sources he amassed for it, appear here. (JORDAN ALL OF THESE PAPER CATEGORIES OUGHT TO BE LINKED.) Whitehead was a major figure in the history of telecommunications in the late 20th century.

Had it been completed, *History* would have provided a broad investigation of electronic communications: “why it is important, what factors are shaping it and what that means going forward for society.”¹ Whitehead had planned to lay out significant moments in the history of telecommunications with a focus on its arc of monopoly to de-regulation while paying special attention to their various economies. He also intended to theorize in the first voice the transformative character and significance of policymaking in the 1970’s in connection to these issues.

As an archive for research, in addition to the draft essay, the site contains 1.95 gigabytes consisting of 446 sound files, 17 video files, and over 700 pages of source material. The materials include *Papers I*, Whitehead’s private papers, drawn largely from his time at the Office of Telecommunications, and *Papers II* A detailed explanation of the contents of this digital archive is below [hyperlink].

About Us

Whitehead conducted the research for his *History* from late 2003 until his death in 2008. Working with assistant Jason Damata, in 2004-2005 he began to assemble, to organize, and to digitize original documents from his entire collection of *Papers* for www.telecompolicy.com From 2006-2008, he worked with research assistant Susan Burgess, who aided his research and writing. Since Whitehead’s death in 2008, his wife, Margaret, assisted by Burgess, has curated his text of *History* and retrieved audio, video, photographic materials, and ephemera to complement the extant draft of *History* that appears as part of the site, www.telecompolicy.com.²

Outline of the materials on this site

I. Papers of Clay T. Whitehead (1968-2008): **[hc]** [hyperlink to longer description]

The largest archive within the papers consists of the almost 28,000 pages collected from Whitehead's tenure as a Special Assistant to President Nixon (1968-1970) and Director of the Office of Telecommunications Policy (OTP) (1970-1974), an agency within the Executive Branch, as well as and Director of the Transition Team for Vice-President Gerald Ford (1974)³ during the last months of Watergate. Among other categories these papers from 1968-1974 include internal policymaking memoranda, congressional testimony, speeches, and correspondence. The OTP papers include two significant

collections: those of Henry Goldberg, General Counsel of OTP [1971-1974] and Bruce Owen, OTP Chief Economist [1971-1972].⁴

II. Draft of the *History* [pd] [hyperlink], with planned *Table of Contents* and some emendations and additions, *Bibliographies I* and *II*, and links to relevant sources. This draft of *History* includes its *Table of Contents*, *Introduction* and *Chapters 1, 2, and 3* in various stages of development. It also includes Whitehead's "Broad Outline" and "Topics Draft" as well as eleven *Chapter Headings*. As for sources, *Bibliography I* consists of 159 used, and *Bibliography II* of 65 intended for use.⁵ All of the print, video, and audio materials cited in both *Bibliography I* and *Bibliography II* are linked here, wherever possible.

III. Primary Sources [mixed pd and hc] [hyperlink]: audio visual materials including interviews, interviews, oral histories, and ephemera (please link). This includes news articles, media interviews and appearances in the form of 17 video files and 446 audio files, numerous transcripts, and various print documents.⁶ Among these materials, are interviews and news articles that describe Whitehead's groundbreaking work in telecom policy and in the telecom industry where, as an entrepreneur, he was a pioneer in the privatization and expansion of satellite telecommunications.

For proprietary reasons the papers from his founding of Hughes Communications and its centerpiece, the Galaxy Project (1977-1983), and the world's first direct-to-home satellite TV broadcast business, ASTRA (1983-1985), are absent from the archive. But there are significant interviews in the Primary Sources (link) that connect to these topics.⁷ By design, the Galaxy Project, a cable-dedicated satellite launched for many generations, accelerated the ascendancy of cable communications. ASTRA's financial and technical models ended the state-owned monopoly over television broadcasting in Europe by bringing viewers hundreds of new free enterprise TV channels.
